The spotlight was on Dallas in February when PACE came to town. The Painting and Coatings Expo proved to be a huge success with educational seminars, trade show, and many social activities.

A new standard was passed during the convention – "PC15-07, Painting of Shop Primed Siding and Other Architectural Features." This brings the number of PDCA Standards to fifteen. All standards are available, in the Members Only section of the PDCA web site, to download and print. They are also available to order in a 3-ring binder through the national PDCA office.

The most significant item on the agenda for the national business meeting was consideration of new bylaws as proposed by a blue ribbon committee. These bylaws would have restructured the national board of directors by dividing PDCA into several regions combined of multiple states/councils. Each region would have then be represented by two board members. One goal of the new bylaws was to reduce the size of the

national PDCA board of directors. Most of the annual business meeting was discussion of the new bylaws – discussion that was often heated. After the vote was taken, the proposed new bylaws did not pass by the 2/3 majority needed.

One unfortunate result of the bylaws result has been the resignation of our own Texas Council PDCA member and National Board Representative Dana Childress. Dana was a member of the blue ribbon committee that spent countless hours, on behalf of ALL PDCA members, to help write the new bylaws. He is passionate in his belief that the proposed bylaws needed to be passed in order to move this association forward. In a letter to Texas Council president, Doug Harms, Dana stated "My anger at the politics and parochial interest displayed on the national level of PDCA is starting to overcome my objectivity. I have served to the best of my ability and no longer feel that I can do the job..... I am now going to take this opportunity to say that it has been a pleasure serving

as the representative for the Texas Council PDCA on the National PDCA board of directors."

Dana's resignation leaves us without a national board of directors representative. The Texas Council PDCA will be actively seeking candidates for the position to be inducted at the state business meeting in June. Their first official duty in connection with National PDCA would be to attend the board meeting in August.

National PDCA also introduced its new magazine <u>DECO</u>. This magazine will be produced directly by PDCA.

Dr. Kerry Johnson was the 2007 PACE keynote speaker. He provided an informative and entertaining presentation on knowing your customers, employees, and co-workers. The Texas Council PDCA has entered into an agreement with IDT Company to provide two different drug testing kits to PDCA members.

These testing devices can be used at any time for random or routine testing and have built in validity tests. Results are available in a matter of minutes.

The iCup tests urine and detects 3-10 drugs. These cups have a shelf life of 24 months and can be stored at room temperature. Results are available within 5 minutes of sample collection and are stable for up to 60 minutes. The iScreen OFT tests saliva with a simple mouth and gum swab. Four, five and six panel configurations are offered to test for an assortment of drugs. Results are available in 5 minutes and are stable up to 60 minutes.
